נושאי הקורס

הכלכלה הבינלאומית כיום עוברת תהליכי גלובליזציה ואינטגרציה. תהליכים אלה צופנים בחובם יתרונות חשובים, אך הם גם מעוררים בעיות. משבר הקורונה של 2020 המחיש את הבעייתיות שיוצרים קשרים כלכליים הדוקים בין מדינות, והוא מעורר backlash כנגד הגלובליזציה. גם הקשיים הכלכליים העולמיים בעקבות המלחמה באוקראינה מבהירים את הבעייתיות הצפונה בתלות כלכלית הדדית.

על מנת להבין את הבעיות שעמן מתמודדת הכלכלה העולמית כיום, קורס זה יעניק מבט רחב על הפוליטיקה של הכלכלה הבינ"ל – הן בתוך מדינות והן בין מדינות. לאחר שנרכוש בסיס תיאורטי, נבחן שורת סוגיות, החל מסחר בינ"ל והשקעה ישירה זרה ועד לסחר בלתי חוקי ואיכות הסביבה.
